Josh to combine a few aspects of a few of the designs to create something we are all in favour of.

7. Communal Management Software for Prince Rupert CL: A presentation with respect to an on-line program that allows the community league to advertise, keep and renew memberships, bookings for community events etc.

David (ex-membership director, Edmonton Meadows) and Wade (cofounder) Started 4 years ago by needing to book a room within a community league.

<u>Problem</u> – Gaps between events, planning, space bookings, volunteers, memberships, etc. within a community league

<u>Solution</u> – Cloud based software will integrate with website. Will handle many issues including memberships and volunteering

- a. Memberships Link presented on website to create or renew membership. Simple form opened in Communal platform
  - i. Can easily add any memberships who sign up with paper
  - ii. Import all previous information stored in excel, etc.
  - iii. Security Stripe is payment processor which is an encrypted database. Even free memberships use this processor
    - 1. If free, can "choose your amount" as a donation
  - iv. Can restrict memberships to PRCL zone (addresses).
  - v. Volunteering option can be chosen if interested in Memberships
  - vi. Digital Membership card EFCL blocks off series of numbers that can be assigned to membership cards to be used at various locations around the city.
  - vii. Membership Renewals
    - 1. Can turn on auto renewals
    - 2. Automated reminders if someone hasn't renewed or set up auto renewal
  - viii. Inactive Users
    - 1. Have an account but no longer are members
    - 2. Easy way to send these users specific emails
- b. Volunteering information can populate those interested by memberships
  - i. Information regarding volunteering can be sent out to
  - ii. Each volunteer opportunity creates a separate link that can be emailed or sent out to members of the community.
  - iii. "View volunteer opportunities"
    - 1. E.g., Casino, can pick individual shifts
- c. Events community events page lists all events
  - i. E.g., Soccer different age groups, different prices for members or not
  - ii. E.g., Garden set up plots, contracts, fees, etc.

Costs - Invoicing, volunteering and Website integration included in all packages
