Anne: Not on radar for the time being.

Growing out has environmental impacts, losing farmland. Resources required increases as you move out.

- c. Solar panels current installations on homes will be impacted by multiple story buildings Anne: Current applications include shadow reviews. Heli ford – complete side of building with solar panels. Residents' rights to light and solar.
