 - ii. Naloxone training free (~15 attendees is preferred)
 - 1. Room for the required amount of training.

 - ii. Roy Explored the following spaces in the vicinity of our community to show costs and amenities.
 - 1. Slo-pitch 325\$ per day/no space during the winter
 - a. Utilize Clansman (see below)
 - b. Meeting room holds 12 ppl max.
 - c. No storage/office/Wi-Fi/indoor events
 - d. Priority to baseball events.
 - 2. Clansman
 - a. 25\$ per hour or \$500 for the entire space
 - b. Would need to negotiate access to kitchen
 - c. Summer would not be available
 - d. Limited storage
 - 3. Midtown mall leasing 1500 sqft 2nd floor
 - a. Requires lease hold of \$150,000.00 plus upfront for improvements
 - b. Steep staircase
 - c. Monthly ~\$2000.00 plus GST plus Wi-Fi
 - d. Limited parking
 - e. ~ \$31,000.00 plus GST for yearly operating costs.
 - 4. Plaza 119 St.
 - a. 3300 sqft
 - b. Requires lease hold of \$150,000.00 plus upfront for improvements

- c. ~\$4000.00 per month plus GST plus Wi-Fi
- d. Operating would be ~\$55,000.00 plus GST
- 5. Aviation museum
 - a. No storage/no kitchen/no office
 - b. Need tenancy agreement
 - c. Not interested but their board would need to be involved:
 - i. Boardroom holds 13 and has computer hookup \$175/day
 - ii. Gallery holds 100 \$1,100/day
 - iii. Classroom holds 20 \$50/day
- 6. Central Lions
 - a. Monthly board meetings are free
 - b. Storage is 2 flights down/ no elevator but no cost.
 - c. ~ \$39,000.00 /year based on calculating usage
 - d. Summer after 17:00 is an issue.
 - e. No access to kitchen
- 7. Queen Mary Park
 - a. Willing to provide basement for \$25,000.00
 - b. Have additional storage \$1,200.00 per year
 - c. No elevator, not barrier-free friendly, not in community (walkability).
 - d. No office space
 - e. ~\$22,500 plus GST yearly
- iii. Having our own building:
 - 1. Rental opportunities
 - 2. Operating is about \$25,000.00 per year
 - 3. Survey results show ~20 ppl who would be willing to lead a program.

 - ii. Majority of PR will change to from Single Detached to Small Scale Residential which will allow for mid-block row housing, cluster housing and small apartments building on the lots currently zoned for semi-detached residential.
