6. City Councillor Anne Stevenson:

A general discussion followed on urban planning issues of note to the Prince Rupert community.

- a. Anne outlined the current position of the City on urban development in general noting that 111 ave. is identified as a major transportation node with potential for infill development.
- b. Also discussed was a specific proposed development of 111 ave and 117 st.

7. City Development Projects:

Discussion on whether the PRCL should create a Civics Directorship to coordinate community communication and involvement on proposed City bylaw rezoning and property development initiatives.

Johnathan Lawrence – (Community Planning Advisor) presenting. <u>jonathan.lawrence@EFCL.org</u>

- a. Purpose of a Civics Director is not to make decisions for the neighbourhood.
 - The role is more akin to a convener to set up structures to hear a diversity
 of voices across the neighbourhood and come to do some public
 engagement.
 - ii. Instead of what we want/don't want, it is a position that asks what the neighbourhood wants.

b. Pros:

- i. Process starting slow and take wisdom of the team; connect with other Leagues with new Civics' position
- ii. Having a dedicated Civics' director allows you to sit at the table. Able to approach district representatives more effectively in some conversations.
- iii. Able to liaise more directly with Community Planning Advisor.
- c. The City is shifting Neighbourhood planning to District planning.
 - i. More involvement from neighbourhoods once a district plan is made.
- d. Community vision This is highly valuable in the eyes of the City.
 - i. Determine what is and what is not available for build.
 - 1. Environmental outcomes: What do we want to preserve?
 - 2. What are things we care about? Parking on streets? Shortcutting through neighbourhoods.
 - 3. Gather input from neighbours.
 - ii. Visions can hold a lot of weight on council. More buy-in, more weight.
