- 4. <u>Alberta Capital Airshed Presentation</u> Selena (Engagement Coordinator)
 - a. A not for profit, multi-stakeholder organization that monitors, reports, evaluates and educates on air quality.
 - b. Primary role is to gather information from air quality monitoring data ensuring all stakeholders, including the public, have access to this important information.
 - c. 88% of population lives within an Airshed region
 - d. Capital region extends up to Athabasca region
 - i. Majority is focused around Capital region
 - ii. St. Albert and remainder around Edmonton
 - e. Monitoring methods
 - f. Data is used to calculate air quality health index (AQHI) (1 to 10+)

 - i. Used to produce annual reports
 - ii. Interactive monthly data

- o. What is a Microsensor
 - Size of softball
 - ii. Provides localized air quality data that is affordable, easy to use and data is publicly available
 - iii. Laser particle counter that measures fine particles commonly associated with wildfire smoke.
- p. Alberta notes:
 - i. Wildfire smoke was the reason for the high AQHI readings in 2023.
 - ii. There were 299 smoke hours in 2023.
